



TATA STEEL (THAILAND)



During Jan-Aug 2024, steel exports from China increased 19% y-o-y to 72.6 Million tons even though crude steel production in China dropped 3% y-o-y.





Thailand / Steel




- Steel consumption in Thailand has been reducing from 2019.
- The consumption in 2023 was 12% lower than 2019. In Jan-Aug 2024, the steel consumption further reduced 1.7% YoY.



- Like overall steel consumption, Thailand's long products steel consumption has been declining. During Jan-Aug2024, it was down by 3.8% y-o-y
- It is hoped that the government accelerates the disbursement of 2024 budget towards the end of the year.



Capacity utilization of steel industry in Thailand remains low compared to other countries in the region




Estimate 2024 capacity utilization of steel industry in Thailand around 28%

Example of Wire Rods

- Imports into Thailand in the first eight months of 2024 increased 8% Y-o-Y
- During first 8 months of 2024, imports from China increased 39% Y-o-Y; during first 8 months of 2024, imports from China were 53% of total imports
- •All domestic wire rod producers reduced their capacity utilization.

Q3 FY25 Outlook



- Monsoon season and heavy flood in Thailand in some regions lead to low demand and lack to purchasing power that affects to place new order and construction work.
- Researcher maintains Thailand GDP growth forecast for 2024 at 2.4%, Gains from the government's cash transfer program to the vulnerable group may get offset by the impact of the flood throughout the country.
- The GDP growth projected to rise to 3.6% in Q4 from an estimated 2.3% in Q3, driven by growth of the tourism sector and a rebound in public spending after earlier delays.
- MPC reduced the policy rate by 25 bps to 2.25% aiming to ease household debt burdens without disrupting deleveraging process.
- Private investment is expected to continue contracting, particularly in residential construction and vehicle investments, reflecting the declining demand in the housing and automobile markets amid rising loan defaults and higher credit rejection rates.
- Total construction forecast starts in Thailand may increase in short-term but the longterm may need further assessment



ESG (Environment, Social and Governance)

- After The European Union (EU) has announced the implementation of the CBAM (Carbon Border Adjustment Mechanism), the direct impact on Thai steel exporters to the EU is higher export costs, such as:
 - **Cost of developing environmentally friendly production lines**, such as Green Hydrogen or installing Carbon Capture and Utilization (CCU) technology.
 - Cost of complying with EU regulations, such as preparing emissions reports and hiring verifiers.
- Another impact is the **increased competition from imported steel**, **especially from China**, which may turn to other countries to replace the EU after the EU announced the CBAM.
- After the EU announced the use of CBAM, China's share of steel exports to 3 groups of countries increased significantly: 1) ASEAN 2) the United States and Mexico 3) the Middle East.
- This has led to each country raising import tariffs on steel from China to curb market penetration, such as the United States and Mexico.
- There are also other ESG issues related to the steel industry that need to be closely monitored:
 - AUS-CBAM of Australia
 - The Thailand Taxonomy Phase 2
